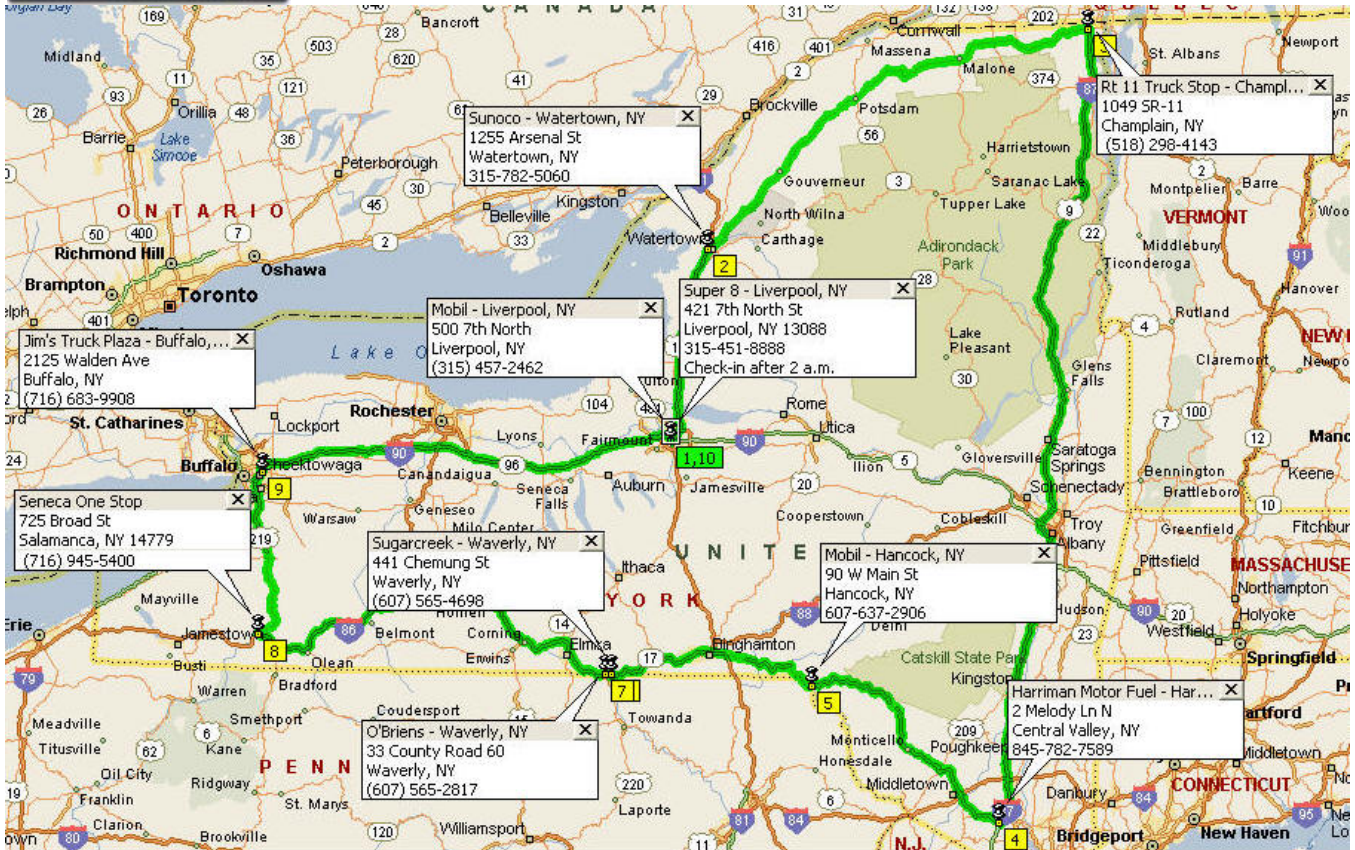

**Warning! You must get leave Highway 17 (Southern Tier Expressway) at Exit 61 and follow local roads to Sugar creek, Waverly, VA and then on to Obrien's for a no sale receipt. This route is an all NY-Instate Route. If you do not follow local roads at Exit 61 you will find yourself in Pennsylvania and your route will be certified as a SS1000 but not the NY In-State SS1000.**

**The Mobil in Waverly is open only open until 11:00 p.m. You should not have any difficulty making this stop. However, if you have had a mechanical problem or some other issue that has slowed you down, you can go into Pennsylvania (a few blocks south and get a receipt). However, your route will be certified as a SS1000 but not the NY In-State SS1000.**
